### **Legal Action Concerning Bury Road Planning Decision**

The permission notice was published 21 August 2020. A letter has been distributed to all households in Woolpit detailing the problem, what we can do and how much it could cost. Residents have been asked if they want Woolpit PC to apply for a judicial review.

### **Woolpit Neighbourhood Plan**

The Examiners Report has now been received. Members of the Parish Council and Steering Group reluctantly accept the changes required by the Examiner but do however see the benefits of having a plan in place in the future and therefore wish to see the Woolpit Neighbourhood Plan go forward to a referendum.

### **Children's Playground**

The playground is being well used. A visual inspection of the area and the equipment is carried out weekly.

**Streetlight 44 The Street (Bury Road) – the telecell is not communicating.** The Clerk is in contact will SCC to ensure that this is rectified so that the light goes out at midnight.

**Pothole Bury Road with crossroads White Elm Road and Broomhill Lane** – has been reported to SCC as a danger to cyclists.

**Drainage issues Drinkstone Road/The Street** – concerns have been expressed regarding the planned work for the development at Old Stowmarket Road feeding into the system at Drinkstone Road/The Street. These have been reported to Anglian Water and an Inspector has been sent to investigate matters and report back.

**Car park opposite the Church** – MSDC has cut back the branches that were obscuring the light and replaced broken fence railings.
